TNT Community Rebate Program – Terms and Conditions (as of May 2011)

ELIGIBILITY

Application for the Community Rebate Program is open to community-based non-profit groups (including registered charities and public sector bodies) that have an established structure allowing for the authority to participate in such a Program and to receive funds on behalf of the group. It must be indisputable to all members that the funds raised are properly accounted for to the members of that group. This Rebate Program is primarily for school greening initiatives but consideration will be given to other groups with 'green' horticultural initiatives. TNT reserves the right to final determination of eligibility and to re-evaluate group eligibility at any point in the relationship through this Program. TNT's decision on eligibility is final.

PARTICIPATION IN THE PROGRAM

To initiate participation, an approved group representative will complete a Program application form. Upon approval, TNT will provide the appropriate quantity of cards to be used by group members. The cards are personalized by organization name only.

ACCUMULATION OF REBATES

Group members must present/mention their TNT Community Rebate card at the time of purchase to earn Community Rebates. All purchases are eligible. Payments can be in the form of: cash, cheque, Visa, MC or AMEX. Debit is available at the Supply Yard only. The rebates from each individual card transaction accumulate into the group's account at TNT. Rebates are calculated at 2% of the gross retail purchase. The Community Rebate card is not a form of payment for TNT purchases.

PAYMENT OF REBATES

Community Rebates will be paid to participating groups on a quarterly basis as determined by TNT. If the Rebate amount payable is less than \$50, then payment will be rolled over to the next quarter when the rebate amount equals or exceeds \$50.

YOUR PERSONAL PRIVACY

You consent to TNT's collection and use of your personal information that is provided to TNT for the purposes of administration, operation, promotion and evaluation of the Program. TNT agrees to hold all such information in confidence and in accordance with TNT's Privacy Policy. TERMINATION, CHANGES AND BREACH

TNT may change these terms and conditions and/or any aspect of this Program (including termination) without notice. For example but without limitation, we may add, delete or change eligible purchases, accumulation or redemption details regarding Community Rebates (ie. the percentage calculation). If your group becomes bankrupt, commits fraud, misrepresents any information, violates any terms and conditions, abuses the Program privileges or acts in any other way to the detriment of TNT, we may, without affecting our other rights, disclose such information requested by proper authorities, terminate your participation in the Program and/or cancel your earned rebates.

GENERAL

The TNT Community Rebate Program is owned and operated by TNT Property Maintenance Inc. These terms and conditions constitute the entire agreement between your group and TNT regarding your participation in accumulating and receiving Community Rebates. Except as expressly contained in these terms and conditions, there are no conditions, representations, and warranties, express or implied, statutory or otherwise. TNT is the final authority as to the interpretation of these terms and conditions and as to any other questions or disputes regarding the Program. All materials and any notices from us will be sent to your address as recorded in our membership account system; please notify TNT if your address changes. If any provision of these terms and conditions is invalid or unenforceable, such provision shall not affect the validity and enforceability of the remaining terms and conditions.
